## Shipped Semen Stallion Service Contract

This service is engaged subject to the following: 1. A breeding fee of \$\_\_250.00\_\_ is payable with this contract. The balance of \$\_\_500.00\_\_ for the first shipment (See #6 below) are due before any semen will be shipped. No contract will be approved until fees are paid. 2. A photocopy of the registration papers (both sides) shall be sent to the breeder with this contract. 3. Shipping days will be: Every Monday, Wednesday, & Friday, beginning February 1 and ending June 1. We highly recommend sending your mare to a vet clinic or breeding farm for her heat cycle. They will coordinate optimum shipping times with us. 4. The Breeder must be notified prior to 9:00 a.m. Central Time on the date the semen is to be shipped. Semen will be shipped on collection days only on an "as available" basis. Mares on premises will receive preference for semen availability. 5. Shipped semen service charge will be as follows: (1) U.S. lower 48 states - Shipped Federal Express Priority Overnight at \$300.00 per shipment. These charges must be paid prior to each shipment. 6. Mare owner assumes full risk and responsibility for insemination of mare, and hereby acknowledges that such and insemination shall be undertaken only by a person knowledgeable in such matters. By executing this contract, Mare Owner agrees that a licensed Veterinarian has examined Mare, that Mare is sound, and is aware of Mare's breeding status. All costs and expenses incurred by Mare Owner in the insemination process and follow up care of the Mare shall be the sole responsibility of the Mare Owner. 7. The breeding season in force for this contract shall begin February 1 and close June 1 of the year on the contract. The only discounts will be for multiple mares bred and multiple world champion mares. Each shipment shall contain enough sufficient live sperm cells to inseminate ONLY ONE MARE. Any attempt to breed more than one mare will void this contract and all live foal warranties herein. 8. Live Foal Guarantee: Live foal means the foal shall stand and nurse within 24 hours of birth. Mare Owner agrees that Madison Wood does not make any guarantee as to the quality, or conformation of the foal, nor that the foal will be free of infirmity, conformation defect, disease, or inherited trait. A return breeding will be guaranteed the following year only, providing proper notification is given. Proper notification is a written certification by licensed veterinarian within seven days that the mare has slipped or produced a non-viable foal. Mare Owner verifies that such abortion or death did not result from any act or omission of the Owner. 9. Rebreds: If the mare does not produce a live foal the first breeding season bred, mare owner is entitled to a rebreed (\$300) the following year after the initial year the breeding fee was paid. Thereafter, mare owner will be subject to a chute fee of \$300.00 and any increases in the breeding fee as well as all shipping fees. No live foal guarantees on the third year. 10. Genetic Diseases: The Breeder shall be held harmless of any horse(s) with genetic diseases (HYPP). 11. A breeder's certificate will be issued to Mare Owner after all expenses have been paid in full and upon notification of birth of foal. 12. There is no Paint Color Guarantee. 13. It is agreed that should above named stallion die or become unfit for service, than this contract shall become

For this with a paid return breeding, if the stallion dies the mare owner may select another stallion standing at Wood and Sons Inc., all monies paid applied to that stallion's breeding fee. Mare owner is responsible for paying the difference in the stud fees if the stallion is chosen with a breeding fee of higher value. There will be no money refunded. 14.This contract is governed by the laws of the State of Iowa and the venue of Floyd County, Iowa. All amounts are due and payable in Floyd County, Iowa, in U.S. Dollars. 15.This contract is not valid unless completed in full. When Mare Owner signs and returns the contract and to Breeder, Breeder will notify Mare Owner within 10 days of approval. Upon notification, it will become a binding contract on both parties, subject to the above terms and conditions. 16.All Futurity Breedings will incur a \$300.00 Chute fee as well as a shipping charge per shipment to be paid prior to shipping.
